Motion to authorize Brad to get Four Private Property signs made and posted. Motion seconded and carried.

Question- Can we get new picnic tables?

Answer- We will table that till the next meeting to see if we have a picnic shelter to put them in.

Question: When will we know what happens with the status of the pavilion?

Answer: The Board will send a notice out updating the members when we have new information.

Motion to not have Board members bid on contracts. Motion not passed.
