Your Board of Directors has discussed the compensation for board members that is presently approved in our By-Laws and would like to recommend a change for your consideration. At this time the following compensation is being paid:

Due to the fashion in which our board functions we feel a fairer compensation would be as follows:

\$200 for Vice-President

\$200 for Secretary

\$200 for Treasurer

\$200 for Environmental Committee Chairman

The By-Laws presently read as follows:

Article V, Section 1.7

The Board of Directors and Officers of the Association may be compensated for attendance at official scheduled meetings of the Board in an amount not to exceed Fifty Dollars (\$50.00)per meeting per month. The President, Secretary and Treasurer may be compensated on an annual basis an additional amount not to exceed Five Hundred Dollars (\$500.00). The Chairman of the Environmental Control Committee may be compensated on an annual basis an additional amount not to exceed Eight Hundred Dollars (\$800.00).

We would like to propose our By-Laws be changed as follows:

Article V, Section 1.7

The Board of Directors and Officers of the Association may be compensated for attendance at official scheduled meetings of the Board in an amount not to exceed Fifty Dollars (\$50.00)per meeting per month. All members of the Board of Directors may be compensated on an annual basis an additional amount not to exceed Five Hundred Dollars (\$500.00).

This suggested change will allow our Vice-President to be compensated the same as the remainder of the board, will not increase our proposed budged, and if approved will take effect starting July 1, 2003.

Your Board of Directors would like to hear from you relative to anything that you feel should be brought to our attention. To make this easier for you we are providing an E Mail point of access for you. It is time this year to elect a new Board of Directors who will serve for a two year term. With the exception of Diane Hunt, who is our present Secretary, all of your present Board of Directors (Bill Hayden, Bob Hargis, Don Burridge and George Franklin) have stated their desire to be reelected. We have also been advised by Rosanne Chandlee that she would like to run for a position on the Board of Directors. If you would like to run for a position on the board please advise our Secretary, Diane Hunt, of your desire in writing. Nominations will also be accepted from the floor at the annual meeting.

We would like to ensure that the entrance to Southwind Shores is maintained in an attractive fashion. We hope to have some additional seasonal plants added to what we have now to provide some added color. We would like to have someone in the subdivision who has an interest in flower gardening to maintain our front entrance. This maintenance would include pruning, weeding when required, adding mulch, replacing any dead plants and watering plants if needed. The cost for any plant replacement would be handled separately and the grass mowing would continue to be contracted out. The maintenance of the plants at our entrance should not consume a large amount of time and we are willing to negotiate financial consideration for the effort. If you are interested in this please get in touch with any of the board members.

Our common area has a dock and boat slips which are permanently assigned to individual off water lot owners. These off water lot owners are taxed on these docks each year by the County and they presently carry an assessed value of \$1,500 each. In almost all associations around the lake off water lot owners pay \$100.00 a year so money will be available when needed to replace the docks. We would like to discuss this topic at our annual meeting to see if there is interest in us setting up and maintaining a "sinking fund" for this purpose. If approved, this would be a service that we would provide for our off water lot owners to help them with future out year expenses and the funds would be maintained in a separate account
